Funding for HIV/AIDS Programme in South Asia

The International Federation of Red Cross and Red Crescent Societies (IFRC) has announced initial funding for South Asia for the 'biggest International Federation AIDS regional programme outside of Southern Africa.'

The IFRC reports that funding has been received for the CHF 15 million, 5 year HIV/AIDS programme which encompasses the national societies of Afghanistan, Bangladesh, India, Nepal, Pakistan and Sri Lanka. The project is being co-financed by the European Investment Bank with a loan of up to €50 million and is supported by technical assistance grants from the EU and Canada.
