Road Safety Legislation Database

The World Health Organisation (WHO) and partners have developed an on-line global database of road safety legislation. This database builds on the comprehensive work already undertaken by the United Nations Economic Commission for Europe Working Party on Road Traffic Safety.

The road safety database provides information on legislation targeting a number of factors that are important for the prevention of road traffic injuries, such as speed limits, safety-belts and child-restraint laws, helmet laws, blood-alcohol concentration limits, daytime running light requirements, mobile phone laws, and licensing regulations. The database can be searched by these factors as well as by country and region. There are also internet links to other informative or legislative documents.

Spotlight on Vietnam



NOW IN VIETNAMESE: Management of Rural Road Networks (Overseas Road Note 20)

Management of Rural Road Networks (ORN 20) written by TRL and funded by DfID, is now available in Vietnamese. The document is targeted at Road Managers who are responsible for the management of a network of low volume rural roads within a constrained budget. Click here to download this resource from gTKP.

Urban Public Transportation in Vietnam

Vietnam is, like many countries, experiencing a rapid growth in its urban centres and in the ownership and usage of motorised vehicles as its economy continues to grow. Urban transportation problems such as traffic congestion and air pollution are therefore becoming important challenges for the nation's two major cities of Hanoi and Ho Chi Minh.

This study by the Japan Bank for International Cooperation (JBIC Research Paper No.4) outlines the current status and issues of motorcycle-dominated urban transportation in both cities. It reviews the present regulatory framework regarding bus transportation, and recommends the regulatory improvements for the promotion of public transportation.

An Introduction to Transport and Roads in Peru

This new report (206 Road Notes Peru) from Schorrell Analysis, in association with Peruvian NGO "ITN Capac Nan", provides a comprehensive introduction to transport and roads in Peru. The document is comprised of introductory briefing and seven short chapters.

The seven topics covered are: rural roads; motocarros (a popular form of low-cost motorised transportation); inland waterways; Inca highways; the use of GIS in Peru; transport and socio-economic problems; and a new tool for evaluating non-motorised transport (NMT) known as ZZE. 206 Road Notes Peru also provides details of organisation working in the country as well as information on relevant websites and internet-based discussion groups. Organisation Profile

The Ethiopian National Forum for Rural Transport and Development (ENFRTD)

The Ethiopian National Forum for Rural Transport and Development (ENFRTD) is a non-governmental organisation, established with the goal of promoting rural accessibility



and mobility. ENFRTD is part of the International Forum for Rural Transport and Development (IFRTD) global network.

The organisation focuses activities around five main issues:

- ▶ The first is to raise awareness of the fact that social inequalities are exacerbated by poor transport. ENFRTD aims to highlight this to encourage responsible bodies to mobilize human and material resources to address these problems.
- ▶ The second issue which has been taken up by the Forum is the transportation of critical patients from rural to urban areas.
- ▶ The Forum is also concerned with introducing affordable intermediate means of transport to rural areas, which can be facilitated by collaborating with stakeholders to set up assistance such as credit schemes.
- ► ENFRTD is also working on addressing the issue of road safety, a critical issue in both rural and urban Ethiopia.
- ► Lastly, the Forum focuses on promoting road safety and bringing services, such as water, closer to people.

Taye Berhanu is the ENFRTD coordinator and also an active member of IFRTD and gTKP.



Participants at the gTKP Tunis workshop in March may have met him there. One of the ways in which ENFRTD raises awareness of these issues among stakeholders is by holding one-day workshops.

Of particular interest is that governance is being placed at the centre of DFID's work. New anti-corruption initiatives are planned as well as an extension of the Extractive Industries Transparency Initiative to construction and other areas.
